#### 12. FIRE CHIEF'S REPORT:

#### City of Placerville

- We are continuing to work with City staff on potential land acquisition for the PSB. The City Council held a workshop on January 30 to discuss the PSB and funding needs for the facility, in addition to other needs within the City. Several different funding sources were identified as options, the Council provided direction to staff for additional information with no action taken.
- We are working with the City and Placerville FSC on their annual Fire Safety Event in March 2024, ECF is one of the sponsoring agencies. We have allowed the Placerville Fire Safe Council to advertise their event with a banner at Station 25.

#### JPA

- We have begun the contract negotiations with the County for our JPA contract with expires on June 30, 2025.
- There has not been any additional movement on the EMS Supervisor position and/or the additional medic unit. The JPA Board is looking for clarity on the funding of these items before taking action.

#### • District information

- The recent storm systems locally have qualified for Pre-Position funding from Cal OES. These funds allow for the upstaffing of additional engine companies and Chief Officer coverage in the County. Our personnel have stepped up, in conjunction with DSP personnel, to staff additional engines during these storms. The District did see some localized damage from the storms a couple weeks ago, primarily due to wind with trees and power lines down. We did have 3 homes significantly damaged from falling trees.
- Sierra Pafic Industries (SPI) has been doing significant tree and brush clearing along Carson Road, near and around Station 21. They offered to remove several of the trees at Station 21 as part of their project, at no cost to the District.
- Annual Live Fire Drills have been completed by all of our personnel. Thank you to Chief McVay, Chief Adams, Captain Lemos and the other proctors for putting these drills together for all our personnel. ECF, DSP and Cal Fire units all participated.
- Staff has been working with AP Triton regarding the Cameron Park Fire Services, mainly providing additional information or clarification.
- The Fire Prevention Bureau is moving to Station 49 the week of Feb. 20<sup>th</sup>. Chief Stirling and Captain Shepard will move initially. Gina Alvarado will be moving mid/late March to Station 49 as well. The Prevention Bureau is notifying the public of this move, the

delay in moving Gina is to further notify the public. In conjunction with the move of Fire Prevention, RTS is setting up a workstation for me at Station 49 to improve some efficiency with daily workflows.

- Our HRT's will be participating in their quarterly training with CHP on March 19<sup>th</sup> in the area of Blue Lakes.
- Captain Rose will be taking the lead on our upcoming Annual Auto Extrication training, March 4, 6 and 8 at the Extreme Towing Yard located at 6590 Commerce Way in Diamond Springs.
- Staff is monitoring the call volume and response statistics of Medic 28 with the recent changes in medic unit locations.

Prince. Director Gilchrest discussed a need for a more in-depth

Emergency Response Plan for the Cameron Park County Club after an unfortunate incident that recently happened. Director Gilchrest provided an overview of a 2 X 2 meeting that he recently had with Director Ogan, himself and Supervisor Turnboo where they discussed the JPA, medic unit out of Cameron Park and the County's financial assistance to cover costs for annexations. Director Gilchrest also provided an overview of a recent conference call he participated in with Chief Cordero and AP Tritan. He

stated he also took the survey that was sent out from AP Tritan.

#### STANDARD OPERATING GUIDLINE

ARTICLE:2 ADMINISTRATIVE POLICIES EFFECTIVE DATE:01/22/2024
AND PROCEDURES

SECTION: 35 CONTINUOUS QUALITY REVISED:

IMPROVEMENT COORDINATOR

#### I. Purpose

a. El Dorado County Fire Protection District is required per El Dorado County Local Emergency Medical Services Agency to provide an agency representative that will attend the regularly scheduled CQI, PAC and MAC, meeting and serve as a liaison between the Local Emergency Medical Services Agency, JPA El Dorado County Fire. This Policy will outline the Scope of Work for the CQIC.

#### II. Definitions

- a. CQI- Continuous Quality Improvement
- b. PAC- Paramedic Advisory Committee
- c. MAC- Medical Advisory Committee
- d. CQIC Continuous Quality Improvement Coordinator
- e. LEMSA- Local Emergency Medical Services Agency
- f. JPA- Joint Powers Authority

#### III. Scope of Work

- a. The CQIC reports directly to the EMS Chief
- b. Scheduled meetings
  - i. The appointed CQIC or designee shall attend the regularly scheduled CQI, PAC, and MAC meeting.
  - ii. An abridgment of key points and considerations shall be sent to all personnel via email.
- c. Data Collection and Analysis
  - i. Gather data on EMS performance, incidents, and patient outcomes.
  - ii. Analyze collected data to identify trends, areas for improvement, and potential risks.
- d. Quality Monitoring
  - Monitor and assess the quality of care provided by EMS personnel and implement mechanisms to ensure adherence to established standards and protocols.
- e. Performance Metrics
  - i. Regularly evaluate performance metrics based on the current LEMSA key performance measures and report findings to relevant stakeholders.

#### f. Training and Education:

- i. Collaborate with training programs to ensure EMS personnel receive ongoing education and training.
- ii. Address identified gaps in knowledge or skills through targeted training initiatives, group training, or one-on-one training.
- g. Communication
  - Facilitate communication between EMS personnel, leadership, and other stakeholders and share quality improvement findings and recommendations with the relevant parties. This will include Monthly reviews submitted by the Base station hospital (Marshal Hospital) and responses to the CQI medical event analysis.
- h. Process Improvement
  - i. Lead or participate in quality improvement initiatives to enhance EMS

processes

ii. Implement changes based on feedback, data analysis, and best practices. i.Image Trend

- i. The CQIC will maintain the status of "Agency Administrator" in the West Slope JPA Image Trend platform along with two additional FTO's (preferably on separate shifts).
- ii. This will give the predetermined designee the ability to unlock ePCR's for correction, update certifications, and add new employees into the system.

j. Annual CQI plan Review

- i. The El Dorado County Fire Protection district CQI Plan shall be reviewed by the CQIC and submitted to the LEMSA no later than 90 days prior to July 1 review deadline.
- k. Performance Improvement Plan
  - i. Performance Improvement Plan shall be drafted by the CQIC in coordination with the FTO and individual under review.
  - ii. The Performance improvement plan will follow the guidelines of the current "Standard Operating Procedure for EMS Continual Quality Improvement."

#### Cardholder Instructions for Use of Your Purchasing Card

#### 1. Purpose

To provide you, the Cardholder, with instructions on the proper use of the U.S. Bank CAL-Card Purchasing Card.

#### 2. Cardholder Responsibilities

You are responsible for using your purchasing card in accordance with your agency's/organization's policies and procedures and any procurement regulations that may be applicable. If required by your agency/organization, retain receipts, sales slips and other purchase documentation, as directed.

- Sign your card in the signature panel.
- Maintain card security to prevent unauthorized charges against your account.
- Obtain a receipt at the point of purchase and verify it for accuracy.
- Reconcile receipts and other purchase documentation to your Cardholder statement, if required by your agency/organization.
- Call U.S. Bank Customer Service immediately to report lost or stolen cards.
- Notify U.S. Bank Customer Service of any billing discrepancies posted on your Cardholder statement that cannot be resolved with the merchant.
- If required by your agency/organization, forward the reconciled statement, purchase documentation, and all associated receipts/charge slips to your manager or designated office.
- Notify your Program Administrator of name, telephone, address or other account changes.
- Do not allow any member of your staff, family or supervisor to use this card. You, alone, are authorized to use this card. It has been especially designed to prevent you from confusing it with your personal credit cards.

#### The CAL-Card must not be used for personal purchases.

#### 3. General Information

- A. This purchasing card has your name embossed or printed on it.
- B. Your agency/organization may have access to the U.S. Bank electronic access system, AccessOnline<sup>®</sup>, for transaction reconciliation and reporting. Contact your Program Administrator for access information.
- C. Your single purchase limit and other spending parameters are designated by your Program Administrator. Contact your Program Administrator if you have any questions regarding your account spending controls.
- D. For emergency purchases that exceed transaction or spending limits, you must contact your Program Administrator prior to using the card, and follow all procedures established by your agency/organization.
- E. Each time you use the purchasing card, there is a purchase authorization process, whereby the merchant seeks approval via a telecommunications system. This authorization confirms that your purchase is within spending limits. Merchants may also call to obtain approval for charges you are making. The dollar amounts of charges authorized (approved) are deducted from your 30-day limit until the charge is billed against your account.
- F. A statement for your account is generated on your cycle date. Each agency/organization will be assigned a unique cycle date (e.g. the 22<sup>nd</sup> of the month). For example,
  - If your cycle is the 22<sup>nd</sup> of the month, your Cardholder statement will be generated at the close of business on the 22<sup>nd</sup> day of every month. If the 22<sup>nd</sup> falls on a weekend, the cycle will end on the previous business day.
  - Charges posted to the account for billing from the 23<sup>rd</sup> day of the previous month to the 22<sup>nd</sup> day of the current month will be reflected on your Cardholder statement.

- If required by your agency/organization, you may also review and approve your purchasing card transactions for your cycle online using the U.S. Bank electronic access system, AccessOnline<sup>®</sup>, transaction management functionality.
- G. Your monthly Cardholder statement may include messages that have been authorized by your agency/organization.
- H. U.S. Bank does not conduct a credit check on your personal credit history before issuing you a purchasing card.
- I. Use of this purchasing card does not relieve you from adhering to all state and departmental acquisition regulations, policies and procedures. If you have questions about procurement regulations, please contact your agency/organization procurement office.

#### 4. Procedures

- A. Card Receipt and Activation: You will be sent a U.S. Bank Purchasing Card after Cardholder Setup has been completed by your Program Administrator and processed by U.S. Bank. You should immediately acknowledge receipt of the card by calling U.S. Bank to activate your account. Call 1-800-344-5696. An Interactive Voice Response (IVR) unit, requiring the use of a touch-tone telephone, will prompt you through the account activation process. You will be asked for information such as your business telephone number, zip code and 16-digit account number. Alternatively, your agency/organization may have determined that a physical card is not required in order for you to perform your duties. This is referred to as a cardless account. In this instance, you will receive an Account Activation letter from U.S. Bank, notifying you of your account number, expiration date and Card Verification Value (known as the CVV2 number). You must follow the same procedures to activate your account as noted above. Cards and cardless accounts are subject to the same activation process upon reissuance.
- B. Card Acceptance: You may use your purchasing card at the types of merchant designated by your agency/organization that accept Visa cards for payment. You may find that some merchants do not currently accept purchasing cards. However, U.S. Bank can assist with card acceptance. For information regarding acceptance, merchants can contact U.S. Bank Merchant Payment Services at 800-432-9413 or merchant@usbank.com.
- C. Purchasing Process: The typical purchasing process follows these basic steps:
  - In-person transactions, Internet, mail or telephone order purchases. Once you have selected
    items for purchase, you can present your CAL-Card to a merchant for payment. When
    placing an Internet, mail or telephone order, you will be asked to provide your name, account
    number, account expiration date, CVV2 and/or your mailing address. Be sure to inform the
    merchant if the mailing or billing address for your U.S. Bank Purchasing Card and shipping
    address are different, otherwise your transaction may be declined.
  - 2. After calculating the total due for the purchase, the merchant processes your card information through an electronic terminal to obtain authorization.
  - 3. The authorization request verifies that your account is valid and determines if the purchase is within authorized spending control limits.
  - 4. Retain your receipt for verification against your Cardholder statement.
- D. Transaction Referral or Decline: U.S. Bank has many safeguards in place to ensure the security of your purchasing card. If a transaction triggers one of these safeguards, it may refer or decline versus being immediately approved:
  - Referral: If a purchasing card exceeds normal transaction activity or authorization parameters, or a particular transaction is identified as high risk, the merchant may be asked to verify additional information or secure additional identification before transaction authorization can be given. This is called a referral inquiry. In referral inquiry situations, the merchant should follow the instructions provided to them by their processing bank, in accordance with Visa Association regulations. The merchant may call U.S. Bank Customer Service requesting authorization to proceed.

- 2. Decline: Purchasing card transactions may also be declined for various reasons. For example, a decline may occur when a transaction exceeds your account's single purchase limit or goes over your total monthly spending limit. A transaction decline may also occur due to the following:
  - a. Your purchasing card account has not been activated.
  - There are too many transactions conducted or dollars spent in one day on your purchasing card account.
  - c. You have exceeded your credit limit.
  - d. An incorrect account expiration or CVV2 value is presented to the merchant on an Internet, telephone or mail order transaction.
  - e. An incomplete or incorrect mailing address is given for an Internet, telephone or mail order transaction.
  - f. You are attempting to make a purchase at an unauthorized type of merchant.
  - g. Situations where it is impractical for a merchant to respond to a referral inquiry, such as an unattended terminal.

Contact U.S. Bank Customer Service or your Program Administrator for assistance regarding a declined purchasing card transaction.

- 5. Authorized Uses: Authorized uses of a purchasing card vary between agencies/organizations. Please refer to your agency's/organization's policies and procedures for specific guidelines and authorized purchase information.
- 6. Prohibited Uses: The CAL-Card program prohibits the purchase of certain items. These include:
  - Financial institution/manual cash
  - Financial institution/auto cash
  - Financial institution/merchandise
  - Non-financial institution/Foreign Currency/Money Order/Travelers Checks
  - Security brokers and dealers
  - Timeshares
  - Fines
  - Bail and bond payments
  - Wire transfer money order
  - Dating and escort services
  - Massage parlors
  - Betting/track/casino/lotto

Agencies/organizations may further restrict the type of purchases you are authorized to make using your purchasing card. Please check your internal policies and procedures for more information regarding authorized and restricted purchases.

#### 7. Procedures After Purchase

- A. Statements: At the close of each billing cycle, you may receive a paper "Cardholder Statement of Account". Your statement is also available in the U.S. Bank electronic access system, AccessOnline. A sample is included in this Cardholder Guide. The Cardholder statement will itemize each transaction that was posted to your purchasing card during the past billing cycle. Below are some general guidelines to consider when reviewing your statement. Complete each of the actions listed below unless your internal agency/organization procedures direct you to do otherwise:
  - 1. Review your Cardholder statement for accuracy.

- 2. Your agency/organization CAL-Card procedures may require you, the Cardholder, to provide a complete description of each item purchased or to keep a transaction log to provide further detail and information on your Cardholder transactions.
- 3. If required by your agency/organization, indicate the accounting code for each transaction. Follow your specific agency/organization procedures regarding use of accounting code fields.
- 4. Attach copies of the sales receipts to your Cardholder statement.
- 5. For payment processing, forward statement and supporting documentation as directed by your agency/organization

Many agencies/organizations will also access transaction information using the U.S. Bank electronic access system, AccessOnline, as an alternative to paper statements. If so, please follow your agency's/organization's procedures for review and approval of electronic statement data.

- B. Electronic Access: Access to your account and transaction information can be obtained through the U.S. Bank electronic access system, AccessOnline. Based on your agency's/organization's policies and procedures, AccessOnline enables Cardholders to:
  - 1. Review and approve transactions
  - 2. Initiate transaction disputes
  - 3. Reallocate charges to specific accounting codes
  - 4. Enhance transaction data

Please contact your agency/organization Program Administrator for a password to access the web-based training for the AccessOnline. The web-based training provides valuable information about the U.S. Bank electronic access system capabilities – including an explanation of access screens, as well as necessary key sequences and functions for reviewing purchases and disputing a transaction electronically.

- C. **Disputed Items:** A dispute is a questionable purchasing card transaction posted to your Cardholder statement. There are several reasons why a dispute might occur. Some examples include:
  - 1. Merchandise/service not received Your purchasing card account has been charged for a transaction(s), but the merchandise or service has not been received.
  - Merchandise returned Your purchasing card account has been charged for a transaction(s), but the merchandise has been returned.
  - 3. Unauthorized purchases A charge on your purchasing card account that you did not participate in and did not authorize.
  - 4. Duplicate processing A charge on your purchasing card account that represents a multiple billing to the account. Only one charge from the merchant has been authorized.
  - 5. Unrecognized A charge on your purchasing card account that is not recognized. A copy of the documentation received from the merchant to certify the charge (sales draft, invoice) will be sent to the account holder for review.

If you encounter any of the above situations regarding your U.S. Bank Purchasing Card account, you need to take action immediately.

- D. Instructions For Disputing A Sales Transaction: Before disputing or questioning a charge on your Cardholder statement, please validate you have taken the following actions:
  - 1. Reviewed your receipts for the amount in question as it may have posted to your Cardholder statement with a different merchant name.
  - 2. Attempted to contact the merchant to resolve the issue.

If the above actions have been taken and you still desire to dispute the transaction, disputes may be filed by phone or in writing using the Cardholder Statement of Questioned Item form (CSQI). Many agencies will opt to file disputes online using the U.S. Bank electronic access system.

For the quickest and most convenient service, please phone U.S. Bank Customer Service and have the following information available:

- 1. The date and dollar amount of the transaction you are questioning.
- 2. An explanation of why you believe there is an error or why you need additional information, along with any documentation to support your claim.
- 3. The date you contacted the merchant to attempt to resolve the issue and the merchant's response.

Many inquiries can be corrected over the phone; however, phoning alone does not preserve your rights. There may be circumstances where written correspondence is required. In these instances, complete the CSQI form. This form is available online or from your Program Administrator. Pay particular attention to:

- 1. Describing the attempted merchant resolution
- Signing the form
- 3. Providing the contact name and corresponding daytime telephone number including area code
- 4. Attaching any supporting documentation such as credit vouchers, and return shipping documents such as postal receipt or UPS receipts, etc.

The CSQI form must be returned to U.S. Bank no later than 60 days after the statement date on which the transaction appeared, in order to preserve your rights to dispute the transaction. Be sure to retain a copy for your files and follow your agency/organization policy and procedure for disputes. If you have questions, concerning disputing a transaction, you are encouraged to call U.S. Bank Customer Service at 888-344-5696 so we may assist you.

- E. Foreign Transactions: Transactions initiated in a foreign currency will post to your Cardholder statement in U.S. dollars. U.S. Bank will provide you with the foreign dollar amount and the exchange rate applied at the time the transaction was processed. A Foreign Transaction fee of two and one-half percent (2.5%) will be charged and incorporated into the exchange rate that appears.
- F. Suspension Procedures: Promptly reviewing your Cardholder statement is essential to enabling your agency/organization to make prompt payment to U.S. Bank. In the event prompt payment is not made to U.S. Bank, your agency/organization is subject to the State of California late payment penalty and is also subject to account suspension and account cancellation actions. In addition, please refer to your agency/organization policy for additional suspension procedures and required timing of account review and reconciliation.
- G. Lost or Stolen Cards: Immediately notify your Program Administrator and U.S. Bank Customer Service in the event your purchasing card is lost or stolen, or if you believe your account number has been compromised in any way.

Provide the following information: Your complete name and card number, the date U.S. Bank Customer Service was notified, and any purchase(s) made on the day the card was lost or stolen.

A new replacement card will be mailed to you within 24 hours and a new account number will be assigned.

In the case of a lost or stolen card, it is important that you immediately notify your Program Administrator and U.S. Bank Customer Service at <del>886</del>-344-5696. Outside the U.S., call collect: 701-461-2010

- H. Cancellation of Cards: If your purchasing card needs to be canceled because you leave your agency/organization or for any other reason immediately notify your Program Administrator and surrender your card. Your Program Administrator will instruct you of any additional action that may need to be taken.
- I. Fraud/Misuse: U.S. Bank's Fraud Prevention Unit continually monitors accounts and transaction to prevent and halt fraud activity. If fraud activity is suspected, the U.S. Bank Fraud Prevention

Unit may contact Cardholders by telephone to inform them about the use (or attempted use) of their purchase card in a fraudulent manner.

Cardholders can help to prevent fraud by carefully reviewing their Statement of Account. If the Cardholder discovers a fraudulent transaction, the Cardholder should immediately report suspected fraud to U.S. Bank Customer Service.

- J. Nonreceipt of Requested Cards: Allow for normal U.S. Postal Service mailing time after a new account is set up for receipt of your card or account activation letter. If you have reason to believe that your card or confirmation should have been received and you have not yet received it contact U.S. Bank Customer Service to verify the mailing date. You may be instructed to report your card as lost in the mail. A new card or confirmation will be mailed to you within 24 hours. A new account number will be assigned to your account. You should immediately bring this situation to the attention of your Program Administrator.
- K. Replacement Card Procedures: If, for any reason, you need to replace the purchasing card that was issued to you, simply contact U.S. Bank Customer Service. A new card will be mailed to you within 24 hours.
- L. Changes to Your Cardholder Information: Any required changes to your Cardholder information, such as name, address, telephone number, e-mail address, organization, 30-day or Single Purchase Limit, restrictions or accounting code should be directed to your program administrator.

- O. TOTAL ACTIVITY: Total balance of purchases and other charges, fees and credits since last statement date

**Subject: DSP ECF Annexation Mapping Project** 

The District is continuing to work with Diamond Springs – El Dorado Fire District staff on our annexation process. One of the required components is a mapping of the entire "new" district. Staff contacted a firm that has completed similar projects within the County for a quote on our project. The initial quote was \$135,000.00. Chief Gallagher and I met with Assistant CAO Hennike regarding the project, she was able to facilitate a meeting with the County Surveyor staff to explore the possibility of the project being completed by County Staff.

Chief Gallagher and I met with the County Surveyor staff; their staff can complete the project for a cost not to exceed \$29,930.00. The project would likely be completed during FY 2024/25.

The cost of the project would be divided equally between Diamond Springs – El Dorado Fire District and County Fire.

Staff would recommend the Board approve the proposal from the County Deputy Surveyor for the LAFCO required mapping project, as presented.

**Subject: JPRIMA Insurance Renewal** 

The District received our annual insurance renewal on March 20, 2024, with a renewal date of April 1, 2024. Our transition in October of 2022 to the Joint Powers Risk and Insurance Management Authority (JPRIMA) changed our renewal date to April 1<sup>st</sup>.

There were a couple of notable changes to the policy renewal:

- Property deductible is now \$10,000 due to the age of our buildings and the wildfire environment.
- All autos have a \$5,000 comp & collision deductible, previously only vehicles valued over \$100,000 had a \$5,000 deductible.
- All properties were increased by 7% for inflation. This was a requirement for ALL departments and was non-negotiable with Munich.
- Atwood ISU was able to successfully negotiate County Fire and some other departments out of a wildfire sublimit
- The annual premium increased from \$166,355.00 to \$201,804.00.

With the cancellation of the March 21<sup>st</sup> Board of Directors meeting, coupled with the short timeframe for signature and the lack of a quorum within the District, the Board Chair authorized the Fire Chief to sign and submit the agreement to Atwood ISU Insurance prior to the April 1 deadline. This ensured the district did not experience a lapse in coverage.

**Property In Transit or Off Premises:** Pays up to \$100,000 for direct physical loss or damage to covered property (real and personal property) while in transit or while temporarily off premises caused by a covered cause of loss, including your covered computer hardware while off premises.

**SCADA Upgrades:** Pays up to \$100,000 to upgrade your scheduled SCADA system after direct physical loss from a Covered Cause of Loss. The upgrade is in addition to its replacement cost. SCADA means the Supervisory Control and Data Acquisition system used in water and wastewater treatment and distribution to monitor leaks, waterflow, water analysis, and other measurable items necessary to maintain operations.

**Unintentional Errors:** Pays up to \$250,000 for any unintentional error or omission you make in determining or reporting values or in describing the covered property or covered locations.

**Personal Effects:** Pays up to \$25,000 for direct physical loss or damage to personal effects owned by you, your officers, managers, elected or appointed officials, employees, or volunteer workers caused by a covered cause of loss at your premises. Will pay up to "replacement cost."

**Lock Replacement:** Pays up to \$25,000 for lock, lock cylinder, & key replacement after theft at covered premises or damage to a lock as a result of a covered cause of loss at a covered premises. No deductible applies.

Foundations: Your real property includes foundations located at a described premise.

#### **KEY DEFINITIONS**

- (a) Means a fortuitous event involving electronic circuitry within covered equipment to suddenly lose its ability to function as it had been functioning immediately before such event. This definition is subject to the conditions specified in (b), (c), and (d) below.
- (b) We shall determine that the reasonable and appropriate remedy to restore such covered equipment's ability to function is the replacement of one or more electronic circuitry components of the covered equipment.
- (c) The covered equipment must be owned or leased by you or operated under your control.
- (d) None of the following is an electronic circuitry impairment:
  - (i) Any condition that can be reasonably remedied by:
    - 1) Normal maintenance, including but not limited to replacing expendable parts, recharging batteries or cleaning;
    - 2) Rebooting, reloading, or updating software or firmware; or
    - 3) Providing necessary power or supply.
  - (ii) Any condition caused by or related to:
    - 1) Incompatibility of the covered equipment with any software or equipment installed, introduced, or networked within the prior 30 days; or
    - 2) Insufficient size, capability, or capacity of the covered equipment;
    - 3) Exposure to adverse environmental conditions, including but not limited to change in temperature or humidity, unless such conditions result in an observable loss of functionality. Loss of warranty shall not be considered an observable loss of functionality.

Outdoor Property: Fixed or permanent structures including but not limited to:

- Docks, wharves, piers, pilings, or bulkheads;
- Dumpsters, concrete trash containers, or permanent recycling bins;
- Electric utility power transmission and distribution lines, poles and related equipment owned by the member;
- Exterior signs not located at a premises;
- Fences and retaining walls;
- Historical markers and flagpoles;
- Hydrants, not associated with a sprinkler system;
- Lighting towers;
- Playground equipment, park shelters, pedestrian-only bridges, picnic tables, water fountains or coolers, benches, dugouts, bleachers, or scoreboards;
- > Storage sheds, garages, pavilions, or other similar buildings or structures not located at a premises; or
- Traffic lights, streetlights, traffic signs, parking meters, or bus shelters.

Personal Property: Means all property used in your operations other than real property, including but, not limited to:

- Furnishings and office equipment
- Building contents;
- Computer equipment;
- Communication systems;

- Materials, supplies (including your inventory of vehicle parts and supplies) while held on your premises awaiting installation;
- Base stations and dispatching systems, provided the property is on your premises and also provided you own the property, or the property is in your custody or control, and you are responsible for it, even though it belongs to someone else;
- Value of your right to use improvements made as a tenant, if you have paid for alterations or additions to any building
  or structure that you do not own (improvements must be at a premises).

**Pollution Conditions:** The discharge, dispersal, release, seepage, migration, or escape of smoke, vapors, soot, fumes, acids, alkalis, toxic chemicals, liquids or gases, hazardous materials, waste materials (including medical, infectious and pathological wastes) or electromagnetic fields into or upon land or any structures thereon, the atmosphere, or any watercourse or body of water including groundwater.

- > Paved surfaces such as sidewalks, bike paths, walkways, patios or parking lots;
- Permanently installed fixtures, machinery, and equipment;
- "Personal property" used for the maintenance and service of buildings or structures, including tools, lawn care equipment, and free-standing appliances for refrigerating, ventilating, cooking, dishwashing and laundering;
- Submersible pumps, pump motors and engines; or
- Underground piping located on or within 100 feet of a "premises" described in the Declarations.

Remediation Expenses: Expenses incurred for or in connection with the investigation, monitoring, removal, disposal, treatment, or neutralization of pollution conditions to the extent required by: (1) federal, state or local laws, regulations or any subsequent amendments thereof enacted to address pollution conditions; and (2) a legally executed state voluntary program governing the cleanup of pollution conditions.

**Tools and Equipment:** All tools and equipment, together with attached devices, accessories and trailers, that are used in your operations. Tools and equipment include, but are not limited to, hand tools, mechanics tools, power tools, meter readers, generators, air compressors, welders, trash pumps, trenchers, saws, jackhammers, maintenance or diagnostic equipment including specialized audio-visual equipment and its associated laptop, as well as recreational equipment, such as outdoor portable seating, temporary stands, food service trailers not licensed for road use, or portable restrooms.

Tools and equipment also include mobile equipment such as, but not limited to, bulldozers, mobile equipment that travels on crawler treads, tractors, loaders, backhoes, excavators, graders, or road surfacing equipment, and equipment whether self-propelled or not, maintained primarily to provide mobility to permanently mounted cranes, shovels, loaders, diggers, and drills. **Subject:** Restructuring of Probationary Firefighter Evaluations

The district has maintained a formal probationary training program which includes required training, daily diligence reviews, formal written and manipulative evaluations. The Training Division and training cadres have been working on updating some of the components to the probationary process, primarily the formal evaluations both timeframes and content. The district has moved to 3/0 staffed engines with a dedicated engineer position which has prompted the discussion to update our process.

The Training Division has recommended the move away from 4 formal evaluations, on a quarterly basis: to 3 formal evaluations every 4 months. The change allows for time and training between evaluations, while maintaining our training standards and requirements.

Subject: FY 2023/24 Budget Adjustment

Since the final approval of the 2023/24 Operating Budget by the Board of Directors, a couple of items have come to fruition that require Board action.

The district received \$1 million dollars from the State of California for the land acquisition of the Public Safety Building – a joint effort with the City of Placerville. Previous Board action approved the movement of the money from ECF to the City of Placerville under joint agreement. This "expenditure" was not included within the Final Budget, as the funds for the project came in at a later date. Line Item 6020 Structures and Improvements will need to increase from \$90,000.00 to \$1,090,000.00, to allow for the transfer of the funds to the City.

The addition of the First Responder Fee Program includes a service fee for billing that needs to be accounted for within our budget. Currently, the fees owed to Whittman Enterprises are being paid out of Line Item 4313 Legal Services/Consultants. Line item 4313 currently is budgeted at \$33,000.00, however, our year-to-date expenses with Whittman Enterprises are \$31,486.00. To capture these expenses and projected expenses for the remainder of the fiscal year, an adjustment of an additional \$42,000 should be made to this line item, bringing the line up to \$75,000.00. The additional costs are covered by the revenue generated by the First Responder Fee program.

Staff would recommend the approval of adjustments to Line Item 6020, increasing to \$1,090,000.00 and 4313, increasing to \$75,000.00.

Subject: Paramedic School Reimbursement

The District has been working collaboratively with the El Dorado Community Foundation for both firefighter training classes and paramedic school sponsorship. The El Dorado Community Foundation has provided significant funding in the past in support of local firefighters, which we are extremely grateful for. Recently, the district has requested paramedic school funding on behalf of two of our members, who are currently enrolled in paramedic school. Unfortunately, our request for sponsorship through the El Dorado Community Foundation was not approved.

The district received a generous donation from a local resident for \$1,000.00 for "Paramedic Scholarship" in early April.

Staff would recommend the Board approve the \$1,000.00 donation be awarded to our two members, currently enrolled as partial reimbursement for their paramedic program.
